Directions to YMCA CAMP SHAND

Coming From Pittsburgh, Harrisburg, and other points west

Go east on the Pennsylvania Turn pike (Rt. 76)
Take Exit 266 (Route 72) Go north towards Lebanon.
Take the exit for 322 East (Ephrata) and go east for about 3 miles
YMCA Camp Shand sign is on the hill on the right
Go down dirt road for 1.2 miles. You will see the Lake, and parking lot on the left.

Coming From Philadelphia, Reading and other points east

Go West on Pennsylvania Turn pike (Rt. 76)
Get off at Exit 266 (Route 72) Go north towards Lebanon.
Take the first exit (Ephrata) and go east for about 3 miles
YMCA Camp Shand sign is on the hill on the right
Go down dirt road for 1.2 miles. You will see the Lake, and parking lot on the left.

Coming from Lancaster, Manheim, and other points south

Head North on Rt. 72 past the Pennsylvania Turnpike
Take the exit for 322 East (Ephrata) and go east for about 3 miles
YMCA Camp Shand sign is on the hill on the right
Go down dirt road for 1.2 miles. You will see the Lake, and parking lot on the left.

Or Take 501 North to Brickerville.
Turn Left onto Route 322 West and travel 5 miles.
YMCA Camp Shand sign is on hill on the left
Go down dirt road for 1.2 miles. You will see the Lake, and parking lot on the left.

Coming from New York, Scranton and other points north

Go South on Interstate 81 to Route 72 South
Head South on Rt. 72 through Lebanon
Take the exit for 322 East (Ephrata) and go east for about 3 miles
YMCA Camp Shand sign is on the hill on the right
Go down dirt road for 1.2 miles. You will see the Lake, and parking lot on the left.

The Lancaster Family YMCA Release and Waiver of Liability and Indemnity Agreement

In consideration of being permitted to utilize the facilities, services and programs of the YMCA for any purpose, including, but not limited to observation or use of facilities or equipment, participation in any off-site program affiliated with the YMCA, the undersigned, and any personal representatives, heirs and the next of kin, hereby acknowledge, agree and represent that he or she has, or immediately upon entering or participating, will inspect and carefully consider such premises and facilities or the facilities and equipment thereon and such affiliated program have been inspected and the undersigned finds and accepts same as being safe and reasonably suited for the purpose of such observation, use or participation. In future consideration of being permitted to enter the YMCA for any purpose, including but not limited to observation or use of facilities or equipment, or participation in any off-site program affiliated with the YMCA, the undersigned hereby agrees to the following:

The undersigned hereby releases, waives, discharges and covenants not to sue the YMCA, its all liability to the undersigned, his personal representative, heirs and the next of kin for any loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by negligence of the YMCA or otherwise while the undersigned is in, upon, or about the premises or any facilities or equipment therein or participating in any program affiliated with the YMCA.

The undersigned hereby agrees to indemnify and save and hold harmless the YMCA from any loss, liability, damage or cost they may incur fully considered and that due to the presence of the undersigned in, upon or about the YMCA premises or in any way observing or using any facilities or equipment of the YMCA or participating in any program affiliated with the YMCA whether caused by the negligence of the YMCA or otherwise.

The undersigned hereby assumes full responsibility for and risk of bodily injury, death or property damage due to the negligence of the YMCA or otherwise while in, about or upon the premises of the YMCA and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with the YMCA.

The undersigned further expressly agrees that the forgoing release is intended to be as agreed and inclusive as is permitted by the law of the Commonwealth of Pennsylvania and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding.
